

Consent to personal data processing

Herewith I give a consent to:

PRONATAL Spa s.r.o., Company Identification No. 046 14 135, with the registered office at: Antala Staška 1670/80, Praha 4 140 00, incorporated in the Companies Register kept by the Municipal Court in Prague under file No. C 250762, (hereinafter referred to as the “Controller”),

to process my personal data: name, surname, date of birth, email address, phone number, in accordance with the Regulation of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter referred to as the “Regulation”), and in accordance with the Act No. 101/2000 Coll., on personal data protection.

I give my express consent to the processing of personal data that is obtained based on an application (web contact form), by means of which I provide the data to the Controller, eventually to the Processor, whom the Controller shall conclude a relevant agreement with.

I acknowledge that:

- personal data processing is necessary to enable the communication between me and the Controller for purpose of negotiations on the conclusion of an agreement,
- personal data shall be processed for the above-mentioned purpose for a period of 24 months unless the data is further stored for a longer period (in accordance with

another legal regulation);

- provision of personal data is voluntary,

- the revocation of a consent does not affect the lawfulness of processing arising from the consent which was given before its revocation.

I have a right:

- to ask the personal data Controller for a confirmation whether the personal data is processed or not; if it is processed, I have a right to ask for the access to such data,

- to ask for the access to personal data,

- for rectification of my personal data (in case of inaccurate personal data) and for completion of incomplete personal data,

- for erasure of my personal data, limitation of its processing,

- to apply with my justified requests to the Controller; if the Controller does not satisfy my request, I have a right to apply to the Office for Personal Data Protection,

- to revoke anytime my consent, free of charge, at **gdpr@pronatal.cz**.
